- b) Identify the premises and conclusions exhibited by the following passages.
- I have a heart and therefore I love
   But I am your daughter and therefore am proud. (4)
- ii) The essence of our admirable economic system is to create wants as fast as or faster than it satisfies them. Thus the improvement of living conditions, meaning greater consumer satisfaction is by definition impossible. (2)
- iii) On the other hand, mothers who breast feed their infants sometimes have trouble with infections. Consequently, mothers perhaps ought not to nurse their infants. (2)
