Zim player gets 10-year ban in UK

ZIMBABWE international cricketer Mark Vermeulen has been slapped with a 10-year ban from the game in the United Kingdom after a violent confrontation with fans at the weekend.

The 27-year-old Vermeulen lost his temper and hurled a cricket ball towards spectators during his club Werneth's match against Ashton in the Central Lancashire League (CLL) in England on Sunday.

The CLL management committee announced on Wednesday it had banned Vermeulen with immediate effect after getting reports from the umpires and the league's chairman and secretary who were present at the match.

"I'm going to appeal and I hope what happened in Lancashire will not wreck my career as I'm returning to Zimbabwe with target of making it to the World Cup next year," Vermeulen told Independent Sport by phone from the UK.

Vermeulen said he went haywire after suffering a torrent of taunts from a section of Ashton fans who he believed were drunk.

One fan is believed to have told Vermeulen that "if you take your sunnies off you'll be able to see where you are bowling" following a wide delivery by the Zimbabwean.

"Some people in the crowd were drinking too much beer and were there to cause problems," Vermeulen said.

"They were having a go at anyone on our team and it's unfortunate all they wanted was to cause trouble."

He, however, could not explain why he failed to control his temper like his teammates who he claims were also taunted. Nor could he say what the actual words that incensed him.

"I was targeted three times and the final straw that broke the camel's back was when I dropped a catch. I just said to myself: 'I'm sick and tired of these people and I must sort them out."

Zimbabwe player banned for six months after doping

BERNE (Reuters) -Zimbabwe international Devon Chafa has been banned for six months after failing doping test fowling a World Cup qualifier against Egypt in June, FIFA said on Monday.

Chafa, who plays for Harare club Dynamos, tested positive for the banned substance prednisone, a glucocorticosteroid, the world governing body said in a statement.

The 22-year-old's ban, which includes domestic matches, was backdated to start on August 30, the day he was provisionally suspended.

Dynamos chairman Kenny Mubaiwa told Zimbabwean media in September that the substance might have present in medication that Chafa took after sustaining a jaw injury in a league match.

Chafa is the fourth player to fail a doping test during the World Cup qualifying competition.
