SECTION A: [COMPULSORY] OUESTION 1

Amanda has just started a business as an organiser of events in the entertainment and events industry. To her joy, she lands a contract with the Zimbabwe Broadcasting Corporation (ZBC) to organise the annual TV awards ceremony which is to be held at 18:00 on the 1st of October 2017. ZBC promises to appoint her to organise the broadcaster's Christmas party if she does a good job with the awards ceremony. Excited, Amanda started planning for the ceremony. She contacts Better Foods Caterers (Pvt) Ltd a firm specialising in catering for high profile events and they agree to provide a buffet dinner at a price of ZW\$30 000 000. The contract signed stipulates that the food is to be delivered at the premises where the ceremony was to be held at 17:00 on 1 October 2017. At 15:00 on the day of the function, Amanda calls Better Foods to make sure that they have the correct directions to the venue. However, all she gets is a message on the company's answering machine stating that Better Foods is closed for the entire week due to staff shortage.

Amanda is frantic. She leaves the following message on Better Foods answering machine, "[h]ow dare you do this to mean, I am cancelling the contract and getting other caterers!" She starts making enquiries from other caterers. The only caterer she can find at such short notice is Gourmet Caterers Pvt Ltd who agree to charge ZW\$35 000 000 to provide the food. In addition, they tell her that they are situated on the other side of town and due to peak hour traffic congestion, they will not be able to deliver the food to the premises before 17:45. To make sure the food arrives before the start of the ceremony, Amanda hires a helicopter at a cost of ZW\$4 000 000 to pick up the food at Gourmet.

At 16:00 just after Amanda had finalised arrangements, Better Foods call her telling her that they just checked their answering machine and were surprised to hear her message cancelling the contract. When Amanda explains that she thought they weren't going to deliver the food because of the message stating that the business was closed Better Foods tells her that it was all a misunderstanding, and that the message on the answering machine was an old message which they had forgotten to delete. In fact, the business had been open all the time. The reason why nobody answered the call was that they were busy loading the delivery truck with food for the ceremony.

Amanda responds by stating that, "it's already too late I have already cancelled the contract and arranged other caterers. I do not want your food anymore."

Advise Amanda on the following:

a. If Better Foods has committed any breach of contract.
